Nick's Notes:

Some of you may have heard the acronym "CHIP" lately. I know there are a few Master Gardeners, such as Linda Werner and Linda Baeten, serving on CHIP committees providing their professional expertise. (Sorry if I missed any other MGs.) CHIP stands for Community Health Improvement Plan. First, I'm writing about this in the event you run across CHIP somewhere in our county and are not sure what it refers to. More importantly though is the CHIP process is moving through the planning stage to the action stage. There are committees formed around these four priorities:
Priority 1: Healthy Lifestyles
Priority 2: Physical Activity
Priority 3: Obesity/Overweight/Type II Diabetes
Priority 4: Healthy Recreation Opportunities

Linda Werner and I happen to be involved on the committee working on Priority 3: Obesity/Overweight/Diabetes. From the meetings I've participated in, Master Gardeners come up often as a possible partner. For example, providing fresh produce to the Oshkosh Area Food Pantry already is a sanctioned project where we have a loose partnership through members to another community organization, the Rotary. Teaching kids about growing and eating fresh vegetables is another topic of discussion. Fortunately, Marge Menacher spearheaded bringing GOT DIRT? to the area so we have members who can use the train-the-trainer approach with teachers and day care providers. The list of examples is long.

Stepping back, we can look at all of the priorities listed above and agree gardening has a place in overcoming this urgent community challenge. This past week at the statewide UW Extension conference, Mike Maddox, Horticulture Agent in Rock County said some thought provoking words about the good of horticulture. His words lead me to believe that horticulture education is not just "nice to have" (this is an infamous critique of University Extension), but essential for the wellbeing of a community. I know the volunteerism within the Winnebago County Master Gardeners is exceptional already, yet I sense this CHIP process is going to open up even more opportunities.

Thank you all for your efforts of the past and those that will come.

What Am I? by Jane Kuhn

I am a late-summer/fall blooming ornamental perennial which is cultivated for its hardiness and low maintenance. I have opposite lance shaped leaves and showy flowers which may be light purple, pink or white. My flowers form along the upper half of my 3-4 foot spikes, in four neat vertical rows and begin opening from the bottom up. My flowers are tubular with white areas on margins and interior. Since my blooms last for about six weeks, you can enjoy me well into autumn.

I am happy in either sunny or lightly shaded spots and am very drought tolerant. Although I prefer a moist, slightly acidic soil, I will grow fine in average or poor soil and then spreading will be less of a problem. I can be propagated by dividing existing clumps in the spring or fall and can be started from seed about two months before planting outside. The biggest maintenance chore is keeping me from rampant spreading. Less or no fertilizing means less aggressive spreading. Besides adding color in fall, I make a long lasting cut flower and also attract hummingbirds and butterflies.

- The sale of Cobra tools was considered a good idea. It's a great tool.

Secretary's Report – Linda Baeten

No corrections were made to the September Board Minutes.

Other Reports:

Nominations and November elections – Audrey

- Ivan will be traveling a lot next year and is concerned about the effect that may have on the office of Vice President.
- No one has stepped forward for Secretary at this point.
- Six people are interested in serving as a Board Member.
- Audrey is looking for biographies from the candidates to publish in the Newsletter before the elections.
- It was suggested to write up "job descriptions" outlining the duties of the Officers and Board Members.
- Linda Baeten will create a ballot form and work with Audrey to list the names of those running.
- The Board will look for a way to keep the pool of candidates, and members in general, engaged.

Publicity – Roy Anne

- Roy Anne passed around the latest draft of the WCMGV Brochure.
- Rosemary Smith has agreed to be the Chair for the Publicity Committee.

OLD BUSINESS

SOP's

Alice had revised the SOP Proposal with changes made from the last few discussions. Ivan asked for input from the Board in hope to present it to the membership in November. It is still a work in progress, and listed below are some of the major changes that were agreed upon:

- Consistency of grammar, specifically the use of "shall" instead of "will".
- Follow the State's SOPs regarding volunteer hours, continuing education and eligibility for certification and recertification. (sections II & III)
- Change "October" to "annually" when it comes to project proposals.
- After some confusion as to whether the word "sanction" is used as both noun and verb, and much discussion, the Board agreed to change "sanctioned projects" to "core projects" as both "core" and "individual" projects have to be approved (i.e. sanctioned).
- Project Leads Responsibilities (section VII) was pared down to make is easier to understand.

- Section VIII regarding the Advisor's Role was changed per Nick Schneider's suggestion.
- A fourth point was added to the Committee Chairperson section IX, B: "submit funding requests to the Board as needed for approval."
- By consensus, the Board agreed to combine the Education and Trip Committee (sections X & XI).
 - The Board also felt this combined section needs to be simplified.
 - Final approval of all trips and education events is the responsibility of the Board.
 - Members who wish to bring forth ideas for trips and events may coordinate and work with the committee.
 - Roy Anne provided a draft to be discussed at the next Board Meeting.
- A change was suggested to the Grant Section XII, B. regarding whether grants from outside sources would need to be passed through the WCMGV treasury. Marge Menacher had specific examples of how this would be difficult in regard to school projects.
- Discussion of SOPs will continue at the next Board Meeting. Ivan noted the changes made this evening and will provide an updated version as decided thus far.

Grant Applications for 2011 – Roy Anne

Since no other suggestions came forth, Roy Anne submitted a grant proposal to the State MG organization for \$500.00 toward speaker fees for Jeff Epping. Applications were due October 1, 2010.

Golden Trowel Awards - Stan

Stan asked that the Golden Trowel awards be put on next month's agenda. Stan, Roy Anne and Linda Tobey are on the nominating committee. Anyone from the membership may suggest a candidate. Candidates must be a Certified MG for a minimum of 5 years.

Other New Business – Kathy

The Oshkosh Garden Club Luncheon to be held on November 20 is open to anyone. Kathy will send an e-mail to the membership.

Answer to What Am I?

I am an obedient plant. Family: Lamiaceae. Species: *Physostegia virginiana*. Other common names are fall obedient plant and false dragonhead. The common name "obedient plant" results from the fact that the flowers will remain in place after being moved. Unfortunately obedient plant is not so obedient in the garden where it can spread to the point of nuisance. Newer varieties like "Miss Manners" are being bred to remain in well-behaved clumps.


